7. To Consider Planning Applications Received:

P1701/13/FUL National Dive & Activity Centre, Day House Quarry. Erection of 12 additional bunk houses with associated timber decking and balustrades – revised information. Whilst No Objection in principle still have concerns over the declared loading which it is understood that the Environment Agency has agreed. The draft licence limits discharge to 20 cubic metres per day whilst the calculation done by the Dive Centre states 18.885 cubic metres per day based on a 2 person occupancy per cabin. Will a condition be placed to limit this occupancy level

P1468/13/FUL National Dive & Activity Centre, Day House Quarry. Siting of mobile home and associated works, driveway and wooden veranda to provide temporary accommodation and the siting of temporary construction site office during construction of staff accommodation in association with the NADC – Retrospective

- 1. TPC would not support any new development in open countryside as contrary to FoDDC policy; this application blatantly constitutes a contravention to the policy
- 2. There is a discrepancy between the 2 GANT documents: the first shows 32 months to completion of the staff accommodation whilst the second (dated 10.01.14) identifies a time period of 47 months. Permission was granted for the staff accommodation block in February 2010 initially but completion now appears to be scheduled for 2017/2018

- 3. The construction office is totally removed from the actual construction site and cannot possibly serve the purpose of the stated use
- 4. The decking is totally disproportionate to the size and use of the proposed (already in position and occupied) dwelling
