## 7 TO CONSIDER OTHER PLANNING ISSUES

a. **To report** on the complaint of noise from Chepstow Racecourse.

**Responses** have been received from Mark Harper MP, Monmouthshire County Council (Licencing department) and the Racecourse Management. The Racecourse management outlines all precautions taken to keep noise within limits and mitigation if limits are breached. They also offered to attend a council meeting to answer any questions from the public.

b. **To consider** the effect of the potential increase in vehicle traffic on pollution in Chepstow.

**Resolved** that the Administrator will look into all monies allocated from S106 agreements of ongoing large developments in Tidenham and Chepstow and prepare a letter to Monmouthshire County Council, FoDDC and Highways.

## 8 TO CONSIDER PLANNING APPLICATIONS RECEIVED

a. **P1563/17/FUL** - The Liam Bond Golf Academy, Tidenham.

Erection of a permeable parking area adjacent to the existing golf ranging facility, to be used as ancillary parking.

**Objection.** Due to the comments made by the Principle Planning Officer and requests for further information by him and Gloucestershire Highways the Parish Council cannot assess this application due to lack of information.

b. **P0101/17/DISCON** - St Mary's and St Peter's Church Car Park, Tidenham Lane, Tidenham.

**No objection**

c. **P1670/17/FUL** - Warehouse Beachley Road, Sedbury.

Erection of 5 new dwellings. 4 x three bed dwellings, and 1 x four bed dwelling house with garage and associated works.

**No objection.** Note Cllrs Birch & O'Toole abstained.

d. **P1674/17/LD1** - Chasecroft, Tidenham.

Application under Section 191 to establish whether continued use and access to proposed new dwelling is lawful.

**The Parish Council** has no objection in principle to the access drive but has no way of knowing whether it was constructed within the period stipulated to begin work when the original permission was granted or whether that permission is still valid to erect a dwelling.

e. **P1663/17/FUL** - Land between 12 and 10A Loop Road, Beachley.

Erection of a detached dwelling house with associated works.

**Objection.** Parish Council objects to this application on the grounds that the size, especially height, of the property is too big for such a narrow plot and would prove overbearing to the bungalows either side. A single storey property would be more suitable. Also the high windows on either side of the proposed dwelling would result in a loss of privacy for the neighbours.

f. **P1769/17/FUL** - Rose Cottage, Beachley Road, Sedbury.

Variation of condition 02 (approved plans) and 03 (materials) to amend the materials and addition of roof windows to the link walkway of planning permission P1707/16/FUL.

**No objection.** Note Cllrs Bollen and Tullett voted against the motion.
