

Your Community Alerts is Gloucestershire Constabulary's new, free messaging system that enables residents, businesses and community groups to participate in a two-way exchange of information about what is happening throughout the county. Whether you live in Gloucester, Cheltenham, Tewkesbury, Stroud, the Forest of Dean or the Cotswolds you can receive up-to-date messaging about incidents that may affect you.

Don't worry, we won't bombard you with every incident. You can choose exactly the type of alert you wish to receive. For example, you can help tackle crime by registering for witness appeals or keep ahead of those traffic jams by registering for road closure alerts. The aim is to send relevant information which is chosen by you and together we can make a greater impact on the prevention and detection of crime and anti-social behaviour in our communities.

The service is entirely free and you can receive the messages in a way that suits you. You may subscribe to alerts via text, an alert through the mobile app, a text or a voicemail. The choice is your hands.

#### **Public Participation at Parish Council Meetings**

Members of the public are welcome to attend meetings of the Parish Council and its Committees. All meeting dates are shown on the Parish noticeboards (Tidenham, Woodcroft, Tutshill Memorial Hall and by the chemist in Sedbury) and the website (www.tidenhamparishcouncil.co.uk). Agendas for each meeting are published on the noticeboards and website on the Thursday or Friday before the meeting. Each agenda will have an item for Public Consultation. At this point on the agenda members of the public present will be invited to have their say. This may be a comment about a Council issue or a planning application for example. The Parish Council may only debate items that have previously been published on the agenda for that meeting so, although Councillors may wish to ask questions of the person speaking, they cannot answer questions asked of them. They may however decide to include a topic on a future agenda.

As for all other parish councils in the country a specific amount of time is allocated for the Public Consultation slot and this is clearly shown on the agendas. Time limitations must be adhered to to allow smooth running and to avoid lengthy meetings. If there are several people wishing to express the same view, a nominated spokesperson can avoid repetition and help keep to the time limit.

Members of the public may not enter into Councillors' debates or speak during any other item on the agenda, so it is important to use the Public Consultation part of the meeting effectively.

# **Sedbury Rainbows**

Sedbury Rainbows have been enjoying the outdoors this summer. We have been using a resource called Rustle, Bustle and Squeak and have had fun making bird boxes, butterfly feeders, stick men and planting herbs.

In the early months of 1917, when German U-Boats were sinking Allied merchant ships at a much faster rate than they could be replaced and Britain faced being starved into surrender, the Government decided to boost shipbuilding capacity by building

three new National Shipyards, the largest of which, No. 2, was at Beachley. What followed was a massive industrial undertaking with the intention of building 18 slipways. In the place of the local residents, thousands of Royal Engineers and German Prisoners of War poured into the area to begin building a massive shipyard to boost Britain's output of new merchant ships. It transformed the village of Beachley, began Sedbury as we now know it and impacted right across the whole parish as far as Tidenham.

# **Community Wellbeing Agents**

L wide service, jointly commissioned by Gloucestershire County Council and Gloucestershire Clinical Commissioning Group.

This new service brings together social prescribing and the village and community agent service, with our former Village Agents now being known as 'Community Wellbeing Agents'. The Community Wellbeing Agents will continue to work very much at community level whilst our Social Prescribing Facilitators remain working out of all our Forest GP surgeries. The service is available for everyone living in the district of the Forest of Dean or who are registered with a Forest GP surgery.

The new service not only supports individuals to self-care and selfmanage to create independency and wellbeing but also supports our communities and our voluntary and community sector to build social and community networks by linking people and community services together as well as encouraging and supporting new community initiatives.

The Forest of Dean Community Wellbeing Team is part of a County The Community Wellbeing team is part of the Forest of Dean District Council's Community Engagement Team and so benefits from a wealth of knowledge and understanding of community based provision throughout the area and is well placed to connect people to access a range of issues such as healthy living, social activity and making friends in the community, help caring for someone, supporting getting back into work, housing-related issues, mental health and wellbeing, bereavement support and much more.....

#### **ANTISOC IAL BEHAVIOUR.** - don't suffer in silence

Antisocial behaviour (ASB) can make people feel Aalarmed, distressed or harassed. It can affect anyone in the community.

Damage to property, street drinking, noise, graffiti, loitering outside shops or homes can all be reported as anti-social behaviour to the District Council, Police or housing providers.

There is now another source of help and information through Victim Support Gloucestershire.

Victim Support's Anti Social Behaviour service offers trained supporters and a specialist caseworker that work with individuals directly affected by ASB.

Victim Support provides emotional and practical support to victims of crime and ASB. All their services are free and confidential.

Victim Support is independent of the police and work closely with other organisations.

If you contact their team, they will make sure you get the information and support you need. This might be arranging a meeting for you to have some emotional support, helping you know your rights, or referring you to other specialist organisations that can also help.

If you are experiencing ASB they recommend:

- · Lock all windows and doors when you are not around
- Call the police on 101 for non emergencies
- Call 999 in an emergency
- Log all ASB activity for evidence purposes
- Talk to someone you trust if you are feeling vulnerable or distressed
- Contact your local authority, housing provider and Victim Support if you need help.

#### **Defibrillators**

wo of the four defibrillators that were bought by the Parish Council with the help of a grant from the District Council have now been installed. One is outside of the Chemist in Sedbury and the other on the wall of the Tidenham War Memorial Hall. Finding a suitable location for the other two has been challenging. The third defibrillator will shortly be installed on the bus shelter at the junction of Loop Road and Beachley Road in Beachley. This unit will be powered by solar panels. As far as we are aware this technology has not previously been used for this purpose and the Parish Council is pleased to be introducing an innovative solution that allows for the use of defibrillators in more isolated places. The Parish Council is hoping to adopt the telephone box in Woodcroft for the fourth defibrillator.

# Tidenham is on a **Pothole Hunt**

**D**otholes have plagued the UK's roads for a long time. Tidenham Parish is not exempt from the decline of our local road network because of the intensity of the traffic, in particular HGV vehicles.

Tidenham Parish council is not responsible for the

b. Visit www.gloucestershire.gov.uk/highways and follow 'Report It' link. This link is relatively easy to use. It takes you through 4 steps to identify where the pothole might be and to what extent it represents a hazard. You will receive an automatic confirmation email with all details in order to follow the progress of the repair online.

In both cases the County Council will decide whether or not a pothole requires urgent repair.

In order for the Parish Council to keep an eye on the progress of the repair of your reported potholes, it would be helpful if you could email the unique reference number (8 digits) as well as the date of reporting to: clerk@ tidenhamparishcouncil.co.uk.

If you find it difficult to use the phone or the web- link the Parish Council is happy to do the reporting on your behalf. You can email the location of the pothole of your concern to clerk@tidenhamparish.co.uk and the pothole location will be entered on the site for you.

Only if local residents in Tidenham join in the fight against potholes in our parish can we improve the quality and safety of our roads.
