Item 11a

A spokesman for several attendees spoke about pedestrian safety between the dual roundabout at Tutshill and Bishton Lane. The main points were:

- i. The bend near the Live & Let Live is dangerous and unsigned. Traffic often speeds around the bend and either crosses the centre white line or contacts the kerb causing damage
- ii. There are not enough speed limit signs along the whole stretch of road
- iii. There are four establishments for children along this stretch of road.
- iv. The volume of traffic, including HGVs is increasing and will continue to do so as more residential developments are completed

Councillors acknowledged the issues raised and outlined ongoing initiatives such as police speed checks and the pending call to Police, Gloucestershire Highways and the Road Safety Partnership for a formal road safety audit in the area. The Parish Council will continue to call upon the agencies to improve road safety but members of the public were also advised to make individual representations to their District Councillors, County Councillor and MP to add weight to the cause.

Discharge of Condition 08 (Construction Method Statement) of planning appeal APP/1615/A/2220590.

Objection

The Parish Council strongly objects to this application.

The inevitable long delay (one year plus) before the main construction can begin will mean that this isolated foundation trench protected by Heras fencing will be an eyesore to walkers on the nearby footpath and a danger to the public, especially children. The trench will fill with water and the fencing is likely to be breached due to vandalism leaving the site exposed. Even with daily checks, as mandated by the CMP, the site is likely to be exposed to youngsters; especially during school holidays and weekends.

The CMP also mandates adequate support infrastructure for contractors working on site and a wheel wash facility for vehicles leaving the site. Neither of which is mentioned in the application.

b. P1321/18/FUL - The Haven, Miss Graces Lane, Tidenham Chase.

Variation of condition 02 (approved plans) to make changes to dwelling fenestration, reduce the size of extension including the replacement of internal garage steps with external ones and alterations to first floor windows.
