Conversion of agricultural barns and outbuildings into residential dwellings.

**12 TO REPORT ON HIGHWAY ISSUES**

**a. Speed indicator trial.**

The trial lasted 5 days and the results show that 61% of drivers exceeded the 30 mph limit; a few as high as 60+ mph. These are alarming figures considering many children cross this road on the way to school and two new junctions are planned to support the 138 new houses being built on both sides of the road. The Administrator will send the report to the Police, Highways and Road Safety Partnership asking for the figures to be corroborated and that a full safety audit of the road be carried out.

**b. Wyebank estate footpaths.**

The Amey Local Highways Manager will inspect the area, meanwhile he will arrange for his team to check for any safety defects.

**c. Sedbury Lane / Beachley Rd flooding.**

The gully and pipeline has been jetted. However, water cannot drain away due to the high level of salt in the ditch. The Area Highways Representative has met with adjacent landowner and has agreed to excavate to lower the level. A works order has been arranged for this and works will be carried out as soon as possible.

**a. Cllr Duff reported the rippling on the roundabout at Beachley Rd and the Link Rd and also the fading white centreline on the Link Road.**

The Admin Assistant will investigate and make the necessary report.
