Resolved to consider the request by FODDC in their "Call for Sites" notice (SHELAA) dated 11 February for suggestions where land in Tidenham could be used for housing and employment. 7. TO CONSIDER PLANNING APPLICATIONS RECEIVED

 P0716/18/FUL – Sheepcot Farm, Miss Graces Lane, Tidenham Chase, Chepstow, NP16 7JR. Conversion of main dwelling into visitor centre, café, shop, offices and staff accommodation. Alterations to barn lean-to to form four stables and veterinary hospital. Conversion of a former milking parlour to create lavatories for visitors and the staff. Renovation of former dairy to create a shop for the selling of donated goods. Plus associated car park and works.

Tidenham Parish Council supports this application, subject to the following:

- Tidenham Parish Council previously commented on 23rd August 2018 and these comments are deemed to be still valid. Residents of Miss Grace's Lane have raised concerns that the access road is not of a suitable standard to accept the extra traffic. The lane's surface is largely un-metalled and Tidenham Parish Council committee is of the opinion that a detailed Highway's audit takes place to ensure the access road is fit for purpose or can be made fit for purpose should permission be granted.
- Tidenham Parish Council would like to request a 20mph speed limit on Miss Graces Lane from the junction with the B4228 to Sheepcot Farm due to increased traffic and the number of concealed property entrances.
- All Public Rights Of Way including footpaths are left unimpeded and maintained.

- **d. Resolved to report** to GCC Highways the increased numbers of heavy lorries using Coleford Road (B4228) and Gloucester Road to access the A48 and the Forest of Dean area. The Clerk's Assistant to draft a response to GCC Highways and MP.
- e. Resolved to note communication received from a resident regarding pot holes and the overall condition of the section of Beachley Road leading up to the sharp bend into Sedbury. Councillors asked the Clerk's Assistant to request the resident report these issues on the GCC Highways Report-It website. Councillors also asked if the Clerk's Assistant can write to the Police and ask if they report highways issues when doing their patrols.

13. FEBRUARY PLANNING DOCUMENTS

a. Resolved Councillor Koning will receive planning documents for February.

14. TO RECEIVE COUNCILLORS' LOCAL REPORTS AND MATTERS FOR THE NEXT AGENDA

- a. Councillor Koning he and councillor Wall are proposing to walk Castleford Hill and using the GCC Highways safety inspection manual and report the various defects with photos and measurements. This report is to be presented to Council and depending on the results of the survey discussed with Brian Watkins, a copy sent to the local MP as well as GCC Councillor responsible for Highways and Patrick Molyneux.
- b. Councillor Koning suggested that Councillors, when they are faced with relevant issues in the parish which require an intervention consider whether or not they can resolve the issue in the first instance by contacting the appropriate agencies, rather than, as a default, request the Clerk's Office to intervene. At a Council/Committee meeting further action can be decided on if required. This is to guarantee that the Clerk's Officers, who are both part-timers, can dedicate their time more efficiently.
- c. Councillor Wall reported the school flashing lights going north towards the school were not working. Councillor Powell advised that there were previous issues with light timing when the clocks changed between summer time and GMT. The Clerk's Assistant advised there is an open report with GCC Highways to have these lights repaired, the school has been informed.
- d. Councillor Tullett reported flooding in Sedbury lane and will report on the GGC Highways Report-It website.
- e. Councillor O'Toole reported a caravan with its tow hook overhanging the pavement causing an obstruction and possible safety concern for pedestrians in Elm Road. Councillor Koning also advised of a large skip placed in a front garden of a property in Elm Road also overhanging the Pavement. The Clerk's Assistant was asked to investigate who these concerns should be reported to.
- f. Councillor Powell asked about the date and venue for the Annual Parish Meeting. Councillor Koning replied this is currently being considered and will be communicated shortly.
- g. Councillor Powell reported the spillage of aggregate next to the compound in Wyebank Road and the reporting of this on Facebook. Councillor Powell also advised the spillage was cleaned up shortly after.
- h. Councillor Drew Reported the developers in Ormerod Road were now using two entrances to the development site and that the grass verge has been churned up by the vehicles entering and exiting the site. Councillor Drew reiterated that the planning application confirms the developers to reinstatement verges when the development is complete.
