- **b. Resolved to accept** those apologies received with reasons for absence.

- a. Resolved to approve as a correct record the minutes of the meeting held on 25th May 2022.
- b. Resolved to consider any matters arising from those minutes.

Page 2, item 12c – Issue with regards marking of the overrun area on the resurfaced roundabout outside Wyedean Fields development was reported to GCC Highways but no response as yet. To be chased.

Page 3, item 14 – GCC Highways have advised that work to cut back nettles and hedges along footpath outside Offa's Mead Academy has been instructed.

- **a. Resolved to note** correspondence received with regards privacy between two properties on the Belway Manor Chase development. Resident was advised to contact FoDDC Planning or the enforcement team if build is not to plan. No further action at this time.
- **b.** Resolved to note correspondence from FoDDC regarding Residential Design Guide Consultation Capturing the Character of the Forest of Dean and an invitation to join a tour. Councillors commented that the Parish Council needs to respond and proposed to consider consultation at the next meeting and not join the tour due to locations all being outside of Tidenham Parish.

Tidenham Parish Council supports this licencing application.

10. TO REPORT ON PLANNING ENFORCEMENTS AND APPEALS

There were none.

11. TO CONSIDER CORRESPONCE RECEIVED RE HIGHWAY ISSUES

- a. Resolved to note the Castleford Hill report received from Councillor Wall. Councillors discussed the seriousness of the issue and agreed that GCC Highways should be considering either cutting bank the embankment or using some of the road to widen the footpath or changing the white lining (remove overtaking lane) to use part of the road as a footpath. Councillors also considered raising the issue with the Police Road Safety officer. Councillor Wall will raise with County Councillor McFarling at the next meeting.
- **b.** Resolved to note correspondence regarding improvements for Sedbury and in particular Sedbury Road surface treatment and wheelchair/pram access to Chepstow. Councillors summarised road surface treatment is the responsibility of GCC Highways and wheelchair/pram access to Chepstow should be considered as part of 11a above.
- c. Resolved to note correspondence received with regards incident relating to speeding outside Broadrock. The Clerk's Assistant was asked to report to GCC Highways and request if 30mph signs on a red background can be painted on the road when entering Woodcroft and if the VAS (Vehicle Activated Sign) can be moved nearer to the start of the 30mph start and better visibility section of road. The Clerk's Assistant to ask the police if a Community Speedwatch location can be assessed, also see item 12b below.
- **d. Resolved to request** more 30mph signs and footpaths be funded from the Highway Local Fund. Councillors suggested 30mph signs on red background be painted on roads that enter the parish on the B4228 Coleford Road entering Woodcroft, Gloucester Road entering Tutshill and Beachley Road

- entering Beachley. And a footpath on the A48 between Rosemary Lane and Hanley's should be considered.
- **e. Resolved to apply** for Wheelie Bin Stickers '20 is plenty' (pack of 100) and the Community Speed Watch Camera from the Community Speedwatch Safety Fund.
- **f. Resolved to note** the 14th June, 2022, Chepstow Transport Hub consultation and completing the survey. Councillors Hartford-Beynon, Koning and Wall, together with the Clerk's Assistant, to complete the survey.

12. TO REPORT ON HIGHWAY ISSUES

- **a. Resolved to note** all temporary road closures notices, blanket order & closure form, road work bulletins, etc received since the last committee meeting have been distributed to councillors.
- **b. Resolved to note** ten people are now trained and signed code of conduct forms for the Community Speedwatch and two Community Speedwatch sites have been assessed by the Police. The Clerk's Assistant to request the loan of the Community Speedwatch equipment and also ask if the Police can assess sites on B4228 Coleford Road, Woodcroft (stretch of road between the Rising Sun and Lancaut Lane) and Beachley Road, Beachley (approach to the Barracks).

13. TO RECEIVE COUNCILLORS' LOCAL REPORTS AND MATTERS FOR THE NEXT AGENDA

Councillor Drew – reported bin collection issues on Denmark Drive where twenty-two houses are affected, issue is related to accessibility for bin trucks. Councillor Drew has escalated to FoDDC and waiting to see improvements.

Councillor Drew – reported issues with road surface breaking up on Denmark Drive and Norse Way. **Councillor Tullett** – reported the issue of parking on the junction of King Alfred's Road and Beachley Road and restricted visibility for drivers continues to be a concern.

Councillor Wall – reported an open gap in the tarmac at the lights at the bottom of Castleford Hill. **Councillor Wall** – asked if there was any news of the daffodil bulbs from Barratts. The Clerk's Assistant advised no and didn't expect to hear until later in the year.
