 - i. UK Safety Store – Aluminium Composite Board (3mm) £19.77 each + Vat = £118.60 total.
 - ii. UK Safety Store – Rigid Plastic (1mm) £13.15 each + Vat = £78.90 total.
 - iii. The Sign Shed – Composite Aluminium (3mm) £14.57 each + Vat = £87.25 total.
 - iv. The Sign Shed – Recycled Plastic (3mm) £8.27 each + Vat = £49.60 total.
 - v. Selectequip – Aluminium Composite Aluminium £9.60 each + Vat = £57.60 total.
 - vi. Selectequip – Foamex (5mm) £7.20 each + Vat = £43.20 total.
